Workshop: Web Scraping with Python (laptop required)

### Abstract

"Scraping" was, until recently, not a very pleasant word. Sometimes a dermatologist had to do it to you; sometimes you had to do it to your car. Regardless, it was abrasive! Now, however, scraping is a fun thing for the whole family to do to the internet! If you've ever wanted to systematically extract data from a series of web pages for later analysis, or just to get a handle on the basic programming needed to do such a thing, this is the workshop for you! Attendees should bring their own laptop; some brief setup instructions will be sent out prior to the workshop itself.

**\*\*NOTE:** you must **bring your own laptop** in order to have hands-on practice.

**Alex Garnett** is Data Curation and Digital Preservation Librarian at SFU. At SFU Library, he works on initiatives relating to the new Research Data Repository. At the Public Knowledge Project, he works on new tools for automatic typesetting and rendering of scholarly articles, and at SFU Archives, he works on implementing digital preservation tools such as Archivematica and BitCurator. ## The Changing Context of Open Data and Information

### **Abstract**

One of the foundations for Open Government is the release of data and information, including through [open.canada.ca](http://open.canada.ca). This is vital for how people understand the workings of government and hold officials and organizations to account, though at the same time the technological environment is changing quickly. This means that data and information governance requires continuous learning and adjustment, and we want to hear your ideas, concerns, and priorities.

This workshop will provide background on the federal government's Open Government work and focus on generating discussion on the changing context of open data and information, how to build on the existing ecosystem, and what the priorities should be for 2018-2020.

**Mark Levene** is the lead for international and intergovernmental work for Open Government with the federal government. Part of the Treasury Board of Canada Secretariat, the Open Government team coordinates and supports work on accountability, transparency, and participation across the federal government. This is done through two-year action plans on Open Government, based on months of discussion with interested and impacted people. Prior to joining Treasury Board, Mark worked at Library and Archives Canada for a dozen years, where he worked on a variety of collection acquisition and management strategies.
